Page 3: B. General Summary of Implementation:Progress and Challenges

Q8 1. What have been the most successful aspects of your implementation of the Partnership? (up to five points)

- a **This questions requires clarification as to whether you are requesting feedback on Secretariat activities, or those implemented by Partners that focus on the conservation of migratory waterbirds and their habitats.**
- b **It is difficult to gauge successful implementation by the Secretariat due to the sporadic nature of communication, and lack of visibility of minutes of meetings from its bodies such as Management Committee, Finance Committee etc.**
- c **It is suggested that the Secretariat examine the independent review report of the Partnership to ascertain any historical successful implementation activities or previous Partner reports submitted to MOPs.**

Q9 2. What have been the main challenges in your implementation of the Partnership? (up to five points)

- a **Lack of transparency, governance and basic administration by the EAAFP Secretariat is a continuing challenge for Partners who require adequate timeframes to undertake consultation, seek approvals etc.**
- b **The voluntary, non-binding framework of the EAAFP is a challenge to implementation as it does not create any legally-binding obligations on Partners. It also does not assist in creating a stable funding base to support activities carried out under the auspices of the Partnership. However, the nature of the framework can also be viewed as helpful when encouraging new Partners and offering inclusion to a wide range of organisations, not only national governments.**
- c **The lack of structure and decision making processes at MOP contribute to challenges in effectively implementing the Partnership.**
- d **Due to the lack of transparency surrounding Management Committee discussions, it is difficult to establish the level of work undertaken by this main body during the intersessional period. Both the Committee and the Secretariat are tasked with a number of activities each MOP, but assessing progress is a challenge.**
- e **The development of a detailed EAAFP Programme of Work and budget could assist in assessing implementation.**

Q10 3. What are the future priorities for your implementation of the Partnership? (up to five points)

- a **Awareness, understanding and implementation of governance documents (Management Committee Terms of Reference, Rules of Procedure)**
- b **Adherence to timeframes outlined in the Rules of Procedure for MOPs**
- c **Adopting clear, professional financial reporting standards**
- d **Developing a EAAFP Programme of Work linked to the Strategic Plan and agreed decisions from MOPs**
- e **A greater focus on Partners reporting against the Strategic Plan and the elimination of work plans. The MOP Partner Reports provides an excellent opportunity for Partners to share what they have actually done during the intersessional period, as opposed to what they might aspire to do.**

Q11 4. Do you have any recommendations on the support needed from the EAAFP Secretariat?

The EAAFP Secretariat's primary functions are to provide administration, governance and communication of the Partnership. While the Secretariat can assist in providing resources such as training manuals, site management guidelines etc, the Secretariat does not need to devote too many resources to undertaking on-ground management and birdwatching surveys. The Secretariat's primary task is to adhere to the governance documents and MOP decisions as agreed to by Partners. The Secretariat should consider taking a greater role in the coordination of migratory waterbird colour-marking. This sort of coordination is perfectly suited to Secretariat responsibilities.

Q12 5. Do you have any recommendations on the support needed from other Partners, Working Groups or Task Forces?

Partners would benefit from the elimination of 'work plans' and a greater focus on reporting on their implementation of the Strategic Plan Targets. Working groups and task forces should have a simple plan that outlines their upcoming intersessional work, and priorities attached to those activities, but it should not be an elaborate document. Working groups and task forces need financial and organisational assistance from the Secretariat to advance their intersessional work. Working groups and task forces would benefit from the support of the Technical Committee to advance their intersessional work. Working groups and task forces would also benefit from having a standard reporting template, different to the Partner reporting template that seeks to highlight key achievements/activities undertaken in the previous intersessional period.

Q13 6. Do you have any other general comments on implementation of the Partnership?

The coordination of colour marking in the EAAF. Australia has taken this role on as the EAAFP Secretariat has not been actively involved in its administration for some time. There is still a clear need for this coordination to occur as had been evidenced by the recent discussion on new flag allocations for various parts of the breeding grounds in the Russian Federation. We believe that the EAAFP would be in a better position to take this role on again through the Technical Committee. At the conclusion of MOP9 in January 2017, Australia made a few suggestions to improve the way EAAFP financial reports are structured. In the past we have had difficulty in understanding the finance reports and the overall financial position of the EAAFP. We suggested that the Secretariat could adopt a clearer template for future MOPs that will assist Partners in understanding the details of the budget and program of work. For example, please see the following link to the Convention on Migratory Species (CMS) 12th Conference of the Parties Budget and Programme of Work 2018-2020 resolution. The information contained in the paper may assist the Secretariat’s intersessional work, particularly in relation to discussing key elements of budgets, fundraising and scenario planning. We particularly like the delineation between core Secretariat work and items that require an additional voluntary contribution from Parties. We also draw your attention to the Execution of the CMS Budget in 2015 and 2016 agenda paper. The reporting format at Appendix II and III is very useful and easy to understand, and something that the Secretariat might consider adopting as we move towards MOP10 and beyond. We understand that according to the MOU concerning Hosting, Secretariat and Administrative Services (paragraph 5 (F)), the Secretariat is subject to internal and external audit review and reports are made available to the Meeting of the Partners. We do not recall this occurring at MOP8 or 9. It would be appreciated if these could be made available in the lead up to MOP10 as per the MOU. It would be most appreciated if the EAAFP Secretariat produced appropriate templates for meeting agenda items (MOP, Management, Finance and Technical Committee). This helps ensure consistency across the meeting documents and demonstrates a professional style of communication.
