# Background

- The Terms of Reference for the EAAFP Management Committee states that **the Committee shall consist of not more than seven (7) Partners, to be appointed by the Meeting of the Partners**, and that: (See next slide – current membership status)
  - i. The Chair of the Partnership (who represents a government Partner)
  - ii. The Vice-Chair of the Partnership
  - iii. The Host Government Partner if not otherwise represented
  - iv. One (1) intergovernmental Partner
  - v. Two (2) non-government Partners
  - vi. One (1) Government Partner not otherwise represented
- The Republic of Korea will continue to serve on the Management Committee as the Secretariat Host Government Partner.
